## GETTING STARTED

1. Go to [ETF-TASC.com](https://ETF-TASC.com) Select Login, then Select the green **LOG IN** button on the menu bar and click the **INDIVIDUAL/EMPLOYEE** option.

3. Enter your email address (PrimaryEmail1) and create a password.
4. To verify your email address, we'll send you an email with a 6-digit verification code. Enter that 6-digit code in the field provided.
5. **Enable two-factor authentication (2FA) to add an extra layer of account security.** When you access your account, we'll send a code to your mobile phone for you to enter to complete the sign-in process.
